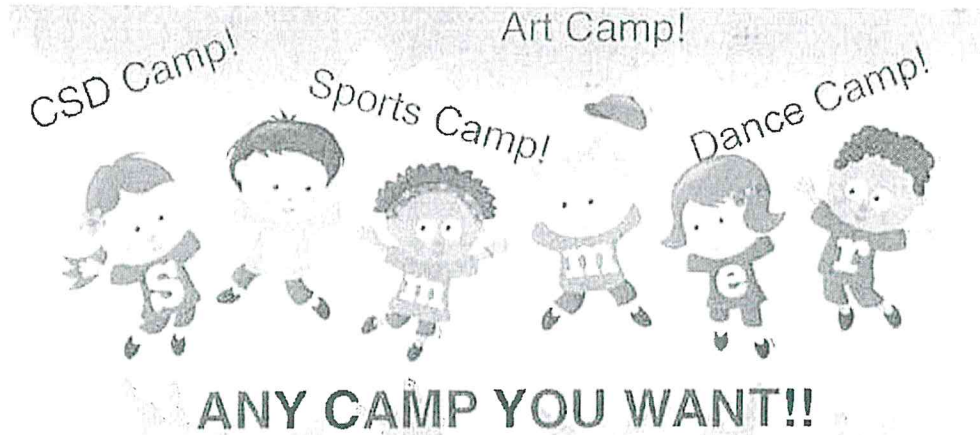


YOUR CHILD'S SUMMER CAMP CAN BE PAID BY THE RYAN HERSH SCHOLARSHIP!!



BACKGROUND: The Ryan Christopher Hersh Memorial Scholarship Fund is a fund that was initiated by the grandparents of Ryan Christopher Hersh in memory of their grandson, Ryan, who passed away at the age of 18. Ryan was an active participant in Hands4Hope for multiple years, assisting with food collection and distribution, homeless outreaches, and mentoring children at a local food and clothing distribution site. Ryan was a kind and gentle young man who served with love, respect, and an open heart.

PURPOSE: To honor Ryan and his love of serving, his grandparents Nancy and Darwin Myers and Sharon and Dick Tietgens created this fund to provide an opportunity for young people to explore their own strengths, whether it be sports, art, music, leadership, or something else, through local summer camps.
